Delhi remains low in 11 months of a year, but picks up in November due to crop stubble (parali) burning in neighbouring states. Dense cloud of smoke covers Delhi, which becomes a gas chamber, the chief minister said.

"The Centre, and the governments in Punjab and Haryana are making their efforts to prevent crop burning and the Delhi government will extend all possible help to them," he said.

Asserting the efficacy of the odd-even scheme, Kejriwal said studies have shown that it could reduce air pollution by 10-13%. The scheme was criticised by some sections, including experts, on the ground that its effect on the air quality was limited. "We will utilise our experiences of implementation of odd-even schemes twice in the past in Delhi," Kejriwal said when asked about overcharging by cab aggregators after the scheme is implemented.
